(AMENDMENT)(NO. 5) ORDER, 2021**

In exercise of the powers conferred by the Emergency Powers (Covid 19 Pandemic)(Management and Recovery) Regulations, 2021, I HEREBY make the following Order —

1. Citation.

This Order may be cited as the Emergency Powers (Covid 19 Pandemic) (Management and Recovery)(North Andros, Central Andros and Cat Island Lockdown)(Amendment)(No. 5) Order; 2021.

2. Amendment of order 7 of the principal Order.

Paragraph (3) of Order 7 is amended—

- (a) in subparagraph (e) by the deletion of the full stop and the substitution of a semi colon; and
- (b) by the insertion immediately after subparagraph (e) of the following new subparagraphs—
 - “(f) a laundromat shall be permitted to operate on Mondays and Thursdays between the hours of 8:00 am and 5:00 pm;
 - (g) no more than one person from each household shall be permitted to attend a laundromat operating in accordance with subparagraph (f).”

3. Amendment of order 10 of the principal Order.

Paragraph (3) of order 10 of the principal Order is amended—
